1. OBJECTIVE

Adopting an approach that prioritises environmental considerations in its operations, minimises environmental damage, trains its employees in environmental awareness, utilises clean technologies, and implements new projects for the protection of the ecological environment, Global Bilgi has implemented this policy throughout its value chain with environmental impact awareness, developing a circular economy consciousness to contribute to the economy and meet long-term environmental sustainability.

2. PRINCIPLES

- Using resources as efficiently as possible in its operations, promoting circularity by applying the principles of reuse and recycling,
- Contributing to the process of establishing public policies aimed at or related to protecting the environment, conducting research and studies
- Developing, using, and ensuring the use of efficient, compatible, environmentally respectful, environment-friendly technologies, products, and services, taking into account their impact on the environment,
- Implementing a "Green Procurement Policy" by taking environmental impacts into account in procurement processes,
- Undertaking initiatives that support new sustainable lifestyles within the scope of standards for limiting greenhouse gas emissions,
- Designing, installing and operating network infrastructures that generate electromagnetic
 emissions and ensuring compliance with legal limits in the purchase and sale of equipment
 and devices capable of transmitting and receiving data and voice over wireless connections
 by adopting appropriate tools, encouraging the continuous monitoring of developing
 standardisation organisations to follow relevant standards in scientific research on the effects
 of electromagnetic fields on biological systems and the human body, and obtain the necessary
 information to take all actions defined within the scope of environmental policy,
- Taking environmental sustainability criteria into account as part of the assessment of potential mergers and acquisitions,
- Making efforts to promote a culture based on the correct approach to environmental issues,
- Engaging in initiatives aimed at reducing the carbon footprint in office practices and business processes, leveraging the digitalisation effect, and developing awareness projects for reducing the carbon footprint among employees, customers, and other stakeholders.

4. ROLES and RESPONSIBILITIES

The Environmental Policy is a document prepared to ensure that Global Bilgi management, employees, business partners, and contractors demonstrate a responsible approach in conducting business in a manner that is mindful of people and the environment.

For this purpose, Global Bilgi develops applications and projects to work in compliance with the Policy and cooperate with its business partners, contractors, and subcontractors.

It engages in activities to encourage other stakeholders to act in accordance with this policy.

The company works to ensure adoption and implementation of the principles and objectives under this Policy.

5. VIOLATIONS OF THE POLICY

In case of any violation of this Policy, the matter shall be reported to the Global Bilgi Pazarlama Danışmanlık ve Çağrı Servisi Hizmetleri A.Ş. Group Campus Services & Occupational Health and Safety Management and Ethics Committee.

In the event of a violation of this Policy, the matter may be referred to the Ethics Committee for consideration of the necessary actions to be taken against the employee who committed the violation. In case of a violation of the Policy by business partners and contractors, the existing business processes will be reviewed.
