#### PRIVACY POLICY

As Turkcell Global Bilgi, we take the following points into consideration in our privacy policy:

#### 1. Information We Collect

Our invitations and questionnaires clearly identify our company and explain the purpose of our outreach when we conduct research.

We usually contact you for either: 1. Conducting a survey interview 2. Making you verify the answers you provided.

We may ask for demographic details such as your age and household composition as well as your personal views when you take part in our survey. You are free to skip any question, discontinue the survey at any time during the interview, or request that your completed responses not be used or be deleted.

## 2. Confidentiality of Survey Responses and Contact Information

We will aggregate your responses with those of other participants and share the results with our customers. We will not disclose your individual responses unless required for specific reasons outlined below. Your survey responses may be collected, stored, or processed by service providers, whether affiliated with us or independent, operating within or outside our organisation. These providers are obligated to share any information they collect or hold with us. We collect this information, declare it to be confidential, and protect it with security standards equivalent to our values.

We will not disclose your information to third parties except in the following circumstances.

1. Your identity information and individual responses may be shared for specific purposes with your consent and approval. 2. Pursuant to ESOMAR rules, your responses will be retained in accordance with the agreement and your information will be disclosed to third parties on the condition that it is confidential, but this information will only be used for research or statistical purposes. 3. Information may be disclosed in accordance with summonses, orders or similar legal provisions issued by judicial authorities and the government. This situation is rare but possible.



**3.** Use of Cookies, Log Files and Other Technologies on Our Website Cookies are small text files stored on your computer that store certain information about your online browser and identify your numerical user ID. If you wish, you can set your browser to delete cookies when you leave the website or close your browser.

## 4. Security of Personal Data

We inform our employees about confidentiality, security and privacy policies and procedures, and the importance of complying with them. We take security measures against situations that may prevent our company from complying with its standards and the laws in the legislation.
